#### **Summary:**

In February 2021, the Minnehaha Creek Watershed District (MCWD) Board of Managers authorized a contract with Smith Partners in an amount of \$50,350, to conduct an analysis of the MCWD's history with the purpose of deriving strategic insights and mapping principles to guide the District into the future.

So far Smith Partners has prepared for and facilitated a kickoff discussion with the Board, to review the strategic arc of the five periods in MCWD's history, and to preliminarily map potential insights and principles. Subsequently, Smith Partners has drafted four chapters, completing historical research, assembling information from archives, and facilitating discussion with the Board.

Some chapters early in MCWD's history required more work than anticipated to gather and synthesize materials from archives, simply due to information not being as readily available or well indexed as more recent time periods. Some of the chapters were also quite dense, requiring multiple discussions with the Board of Managers. As discussed with the Board, the work to date has consumed a majority of the budget. Currently there is \$1,485 remaining in the initial budget.

Based on the work and experience to date, Smith Partners has prepared a scope of work in an amount of \$34,787, to complete the project. This work includes completing the research and drafting of white papers, refining chapters 1-5 with citations and incorporation of feedback from the Board, and the distillation of insights and principles which are to be workshopped and discussed with MCWD Staff and Board. The final work product will be assembled with an introduction, the individual white papers, and a conclusion section which memorializes the guiding principles.

#### **Recommendation:**

At the April 28 2022, Meeting the Board of Managers will be asked to authorize a second phase contract with Smith Partners PLLP to complete the strategic analysis work, in an amount of \$34,787.

WHEREAS,	2022 represents the midpoint of the Minnehaha Creek Watershed District's 10-year plan, and is also the 5 year anniversary of the District's 2017 plan for strategic alignment.	
WHEREAS,	as the District approaches this midterm milestone the Board of Managers has expressed a desire to continue strategic preparations for the future.	
WHEREAS,	the PPC engaged in a series of discussions to clarify the purpose and focus the process for these discussions.	
WHEREAS,	pursuant to Resolution 21-013, the Board of Managers authorized a contract in the amount of \$50,350 with Smith Partners PLLP, whom the Board found uniquely qualified to complete the work given their decades of history strategically advising MCWD, to conduct an analysis of the MCWD's history with the purpose of deriving strategic insights and mapping principles to guide the District into the future.	
WHEREAS,	the completion of research for earlier chapters in MCWD's history was more involved than originally anticipated, due to the availability and indexing of information in archives, which has consumed a majority of the approved budget.	
WHEREAS,	the need for a second phase contract was previewed during presentation of the last white paper, in MCWD committee.	
WHEREAS,	Smith Partners has assembled a second phase scope of work to complete the project, in an amount of \$34,787, to complete remaining research, draft remaining white papers, refine all white paper chapters based on feedback to date and to include citations and references, to distill the insights and principles, to facilitate staff and Board workshops and discussions, and to assemble into a final package.	
WHEREAS,	the Board of Managers has reviewed the proposed scope of work and finds the analysis of MCWD's history and the resulting guiding principles as valuable contributions to the District's ongoing success and future alignment.
